Partners and Capstone Admins will have access to all reports.

Vendors will only have access to the Vendor Detail and Vendor Summary reports.

Capstone Logistics \triangleleft Manage Violations User Provisioning Admin Report TEST PARTNER - Chris Ricciardi -Report **DC Detail Report** Provides information on the violation and approval process by PO by DC. All PO's can be shown to track check in/out times. Vendor Detail Report Provides detailed receiving information on PO's. Vendor Summary Report Provides PO Compliance performance metrics by DC and product group. Vendor Exception Report Displays preferred vendors that are exempt from violation fines. **Carrier Exception Report** Displays preferred carriers that are exempt from violation fines. Vendor Exemption Audit File Download an exemptions audit file report by vendor.
